Use of the substance/mixture: Carprofen Injectable is indicated for the relief of pain and inflammation associated with osteoarthritis and for the control of postoperative pain associated with soft tissue and orthopedic surgeries in dogs.

2.1. Classification of the Substance or Mixture

Classification (GHS-US)
